### **Application Information/ Festival Rules and Fees**

**Application Deadline:** To be considered for the show, the application must be postmarked by August 30, 2016. No late or incomplete applications will be accepted.

**Eligible Entries:** This show is for original work only. No resale please. The committee will reserve the right to prohibit the display of any work it deems inappropriate for a family show.

**Booth Space Fee:** 12' x 5' space is \$ 106.00, which includes sale tax. Space is under cover. Tents will not fit under cover. Space fees include all applicable taxes. Space fees are non-refundable after acceptance has been mailed.

Your work and belongings – including chairs – must be contained within the assigned booth space. Booth spaces may not be changed without the approval of the show director.

The crafts people accepted are responsible for their own set-ups.

Notification of Acceptance: Notification will be mailed by Sept. 15, 2016 – space assignment and map will be included/

**Exhibitors:** All exhibiting artists (collaborative and otherwise) are required to be present for the duration of the show (10am through 5 pm).

**Taxes:** Each exhibitor is responsible for collecting Florida Sales Tax and reporting it directly to the Florida Department of Revenue. You can register for a sales tax id# <a href="https://www.myflorida.com">www.myflorida.com</a>—they will check! Alachua County sales tax is 6.00%.

**Check-in and Set-up:** Check in between 7am and 9am on Saturday November 19 – all must be set-up by 9:30am. Check in is in fron of A1 Sewing on the west side of Thornebrook Village.

**PARKING:** At check-in you will be given the locations of parking spaces. Vehicles MUST be removed from the Thornebrook Village parking lots by 9 am on Saturday. Thornebrook will tow!
